• From MK Council Officer Gareth Hughes - As you will be aware we have been in ongoing discussions with Anglian Water regarding their proposed scheme on Cranfield Road and Newport Road. I can now say that despite our continued meetings with them, we have not been satisfied that they are ready to undertake their works on Cranfield Road. We have therefore decided to revoke any permissions they have until such a time as Network Rail have given AW full approval for the crossing of the railway. The closure of Cranfield Road which was proposed to start on 14th February has therefore been postponed until further notice. This will also mean that we will have to delay the delivery of the new footway on Cranfield Road, which we were initially intending to install as a continuation of the road closure in February. We will keep you updated with future discussions on both of these schemes. Therefore a meeting at present is no longer necessary.

I do hope this will help but residents and businesses minds at rest for the time being.

The original decision of 30 November was subsequently called-in by two parties (Councillors David and Victoria Hopkins, and Bow Brickhill Parish Council), but further to informal mediation, the outcomes of which are set out at Annex D, both parties withdrew their call-in.

There were a variety of mediation outcomes, including that the decision to adopt the SPD be retaken by the Leader of the Council on 11 January 2022. A further key outcome was that an additional paragraph be inserted into the SPD making it clear that any change of location shown for Woburn Sands Railway Station is indicative only and that it in no way provides the EWR Company with the opportunity to maintain that this is the Council's final position and should not therefore be open to further debate in the upcoming EWR Statutory Consultation.



Making Improvements to MKC Planning Services

A Planning Improvement Board (PIB), chaired by the Deputy Chief Executive, was formed in 2020. It oversees improvements to the Planning Service, particularly operational processes within the Development Management (DM) function. Risks and issues within these processes were highlighted by the 1 Yeomans Drive (1YD) planning application. An Interim Improvement Plan (IIP) was developed in 2020 following a review of the Planning Advisory Service (PAS) DM Challenge Toolkit, completed by the Service the previous year. The PIB meets every 6 weeks to review performance, receive progress reports and deal with escalations arising from the IIP. It is proposed the IIP now evolves into a final version of the Improvement Plan. This is so it can reflect the independent investigation into 1YD and any recommendations from the Local Government Association (LGA) Peer Review being undertaken in late February/ early March 2022, as per Council Plan Commitment 18

Milton Keynes ranks among the strongest and most resilient local economies in the country, finds a report published today.

The Cities Outlook 2022, suggests that MK is well placed to make a strong initial recovery from the pandemic, with the potential to become one of the UK's leading economies if future levelling up policies from central government are implemented.

The latest data shows that MK sits among the top ten cities when it comes to new business startups, productivity and housebuilding rates.

Cities Outlook 2022 analyses the short-term impact of the pandemic on Britain's town and city centres and the long-term consequences and implications this has for the Government's levelling up agenda.

Since the pandemic began, MK Council has distributed vital financial support through almost 20 different grant schemes for local firms, giving out over 11,500 grants to businesses totalling £64.7m. The Council also has a £3.1m economic recovery package to support businesses and provide training to help local people back into work.

Leader of MK Council, Cllr Pete Marland said: "MK is the place for good, well-paid and secure jobs. While the initial signs of economic recovery are encouraging, we cannot be complacent. The

report is clear that there is a real danger of levelling-down if policies are not put in place to support businesses in places like here.

"We have a good track-record in MK of dusting ourselves off and coming back stronger in times of economic uncertainty. It's thanks to our citizens and business community that are helping us to deliver a prosperous, green and fair recovery from the pandemic."



Bus Services

On April 1 2021, MK Connect was launched Borough wide in Milton Keynes to provide a public transport service to residents and visitors that were not on commercial bus routes. MK Connect is the first DRT scheme of its size in the UK and the first in the UK to integrate with the commercial bus, directing users on bus routes, to the bus route.

The previous subsidised fixed bus routes were withdrawn as they were not financially sustainable long term. COVID 19 added a greater time pressure to finding an alternative solution, but the issue was long standing as costs continued to increase, patronage to fall and developer funds continue to run out increasing the subsidy direct from the Council

Council Budget 2022/23

Since 2010 Milton Keynes Council has had to make over £170m in savings and cuts while dealing with an increase in demand for important services such as adult social care. The Revenue Support Grant received from Government has been reduced by 90% in that time.

Our overall financial position continues be very difficult and we must identify £5m of savings to balance the draft budget. Despite this, we are not proposing any major changes to services.

Budget 2022 proposes:

- •A below inflation 3.75% increase in Council Tax (1.99% Council Tax and 1.76% adult social care precept).
- •The use of £3m of reserves to cover one-off reductions in income due to Covid-19 and spending pressures.
- Efficiency and productivity savings of £2m.

In addition, it proposed continued investment in support for vulnerable young people and families; extra support for emergency accommodation for homeless families and rough-sleepers; and additional funding for specialist autism and mental health services.

It also includes extra funding to retain weekly general waste collections, boost recycling and roll out wheelie bins across the city in 2023; increased funding to reduce fly-tipping and litter and to tackle rodent issues; money to improve landscaping and the appearance of grid roads; and investment in more gully, drain and flood prevention works to mitigate the impact of climate change.

Starting this month, more than 80 street name plates across MK's residential streets and grid road network will be repaired or replaced as part of a large maintenance programme.

A further 36 plates where the street name is no longer visible will be fitted with a new printed wrap. The full list is available to view at: https://www.milton-keynes.gov.uk/highways-and-transport-hub/roads-redways-and-footways/road-signs

Street name plates are essential to help provide location information for emergency services, taxis, delivery companies and local residents.

The list of street name plates has been compiled based on priority so that any signs that are completely missing will be done first.

The Council's highways service provider, Ringway now produces the printed name plate wraps in house. This means that replacing faded signs can happen more quickly and the cost savings can be used to include more street name plates in the repair programme.

MK's community safety partnership has launched a survey to gather local people's thoughts ahead of the introduction of new government legislation

Have your say before 7 March







The community safety partnership for Milton Keynes has launched a public survey to gather local people's thoughts ahead of the introduction of new government legislation.

The new national Police, Crime, Sentencing and Courts Bill 2021 is set to be introduced by the government and as a result, all local community safety partnerships across the UK have been asked to identify any serious violence that occurs in their area, its causes and a strategy to prevent it.


SaferMK, the community safety partnership for Milton Keynes and made up of representatives from MK Council, Thames Valley Police, Bucks Fire and Rescue, the NHS and local community groups including the MK Dons SET, has produced its Serious Violence Strategy in response to the new government requirement and is asking local people to have their say on it in the online survey. The SaferMK partnership works together to deliver a range of community safety initiatives in Milton Keynes.

Over the last three years and working with its SaferMK partners, MK Council has committed £350,000 to deliver projects aimed at early intervention, which have most recently included a new knife crime prevention learning zone at the Safety Centre Hazard Alley, as well as a youth outreach programme, mentoring scheme, street art parkour workshops, mental health support and speech and language provision.

SaferMK's new Serious Violence Strategy sets out proposals focusing on five main areas including early intervention and prevention, shared information and intelligence, tackling drugs and county lines, engagement and community support, as well as law and enforcement.

Cllr Lauren Townsend, Cabinet Member with responsibility for Community Safety at MK Council said: "We've produced our Serious Violence Strategy in response to the new government requirement, and it's been a good opportunity to reflect on the good work we've done to date. We'll continue to work with our local partners to ensure Milton Keynes stays a safe place to live, work and visit. Please have your say in the online survey to help develop the new strategy." MK continues to smash housebuilding targets

Council Leader Pete Marland with Jodie (Barratt Homes) and John (Barratt Homes) Almost 6,000 much-needed new homes have been built in Milton Keynes over the last three years as new figures show the city is beating its housebuilding targets set by central government for the fourth year running.

The latest Housing Delivery Test (HDT) which illustrates the number of homes built in each council area, shows that Milton Keynes is building 128% of the number of homes in its target. Areas that don't meet the national requirements face losing their planning powers to central government. MK Council has been instrumental in the success by adopting a Local Plan that sets out the vision and ground rules for developers and ensuring its development management service is making the housebuilding process smoother.

The results from the HDT show MK delivered 5,850 new homes in the three years from 2018/19 to 2020/21 - 28% above target. Of these 1,204 are affordable.

This puts MK on a level-footing with its neighbours. Milton Keynes Council is preparing to become a full member of the Central Area Growth Board in the Cambridge-MK-Oxford growth corridor, which will allow the council to proactively shape the future growth of MK.

Earlier this week, Council Leader, Pete Marland visited the Fairfields housing site being built by Barratt Homes which will have over 2,000 new homes once fully completed. Barratt is one of the largest housebuilders in the country, having built over 600 homes in MK last year.

The Council has also set out its own ambitious and housebuilding plan, with proposals to deliver 1,200 council homes by 2030 that will be some of Milton Keynes' most accessible, environmentally friendly and heat-efficient properties.

Leader of MK Council, ClIr Pete Marland said: "These numbers are really encouraging and tell a great story for Milton Keynes at a point when many other authorities are lagging behind on their targets. However, we want to see more homes being built that are genuinely affordable to people's income, and we'll keep using our influence to make that happen.

"Meeting our housebuilding numbers from Plan:MK is really important for protecting Milton Keynes from unplanned speculative development that can happen when targets are not met and helps us maintain the unique character of Milton Keynes, as well as helping local hardworking families."

Community to take ownership of local open space and children's play area

Walton Community Council is set to take ownership of the open space and play area at Hindhead Knoll in Walnut Tree as part of MK Council's proposals to give greater powers to local communities.

The transfer will allow Walton Community Council to provide better leisure and community activities for local people for generations to come. Hindhead Knoll is a much-loved space for residents of Walton and is known for the Community Council's popular annual Summer Fayre, Christmas Celebration and various community engagement events.

The Council hopes that by putting more community facilities in the hands of the people and organisations that use them, it'll encourage greater investment as well as continuous and sustainable use.

MK Council has worked closely with Walton Community Council on this area, which now includes a refurbished play area, uplighters, new safety crossings, picnic tables, noticeboard, raised shrubbery bed, the Little Free Library and an events shelter.

Additional money to enhance the area will also be made available from developer contributions as the site falls near a new development.

Cabinet Member with responsibility for asset transfer, ClIr Jane Carr said: "We're delighted that we're handing over yet another much-loved local facility to Walton Community Council. Working alongside local people, the community council will have power over what goes on at Hindhead Knoll as they are best placed to serve the needs of their community."

"Walton Community Council's Council Manager, Lesley Sung said: "We are delighted to take ownership of the land at Hindhead Knoll. This is an important area for us and is central to our key strategic aim of enhancing our community. This area will enable us to provide facilities and exciting new events for all ages that will bring our community even closer together."
